- Experience an unexpected financial hardship resulting from the COVID-19 outbreak.

**What expenses are covered?**

Although there are varying expenses associated with the COVID-19 outbreak, the following are examples of costs covered by the Coronavirus/COVID-19 Emergency Fund:

- Food, Housing, Course Materials, Technology, Health Care, and Child Care Expenses;
- Travel Expenses (as a result of the COVID-19);
- Homelessness or sudden loss of housing (as a result of the COVID-19);
- Overdue utility bills reaching a turn-off notice (as a result of the COVID-19).

Due to the limited funding available, requests made for expenses beyond the Spring 2020 semester may not be considered at this time. Eligible students may only receive the funding once via the Coronavirus/COVID-19 Student Emergency Assistance Application. Funding awarded/received through this grant does not need to be repaid. Funds awarded can **ONLY** be disbursed in the form of a check made payable to the student.

**How Do I Receive Funds?**

Students identified by the Office of Financial Aid as initially eligible (based on the above guidelines) were notified on **May 4, 2020**. Students must follow the link provided within the email to certify that funds awarded will be used for allowable expenses. Funds will not be disbursed to students who have not submitted an application/certification form. We are asking all students who received a notification to submit their form by **June 30, 2020**.

Upon receipt of the application/certification form, funds will be disbursed via check to students. Checks will be mailed to the address on file with Talladega College unless the student has provided an alternative mailing address.

**To date, the total number of students that have received Emergency Financial Aid Grant?**

As of **June 8, 2020**, Talladega College has disbursed **\$393,500** of Emergency Financial Aid Grants to our students pursuant to **Section 18004(a)(1)** of the CARES Act. Out of the 918 eligible students, 772 students have applied and received their Emergency Financial Aid Grant.

**When Can I Expect to Receive the Funds?**

The College will process fund disbursements **weekly** through **June 30, 2020**.
